The Fate of Little Gull Island to Be Decided in a Few Days

Little Gull Island, located between Plum and Fishers Islands in Long Island Sound, is among a group of former Coast Guard lighthouse properties being sold by the General Services Administration (GSA). Though only one acre in size at high tide, Little Gull, with her neighboring islands, is vitally important to wildlife, serving as a stopover for migrating birds and seals and as a safe place for nesting and foraging in the nutrient-rich waters surrounding the islands. We must do all we can to protect Little Gull Island from development.

Please join the New London Maritime Society, in partnership with Save the Sound, Connecticut Fund for the Environment, Quebec-Labrador Foundation and several environmental foundations and organizations in an urgently important letter writing campaign to tell the GSA that you support the preservation of Little Gull Island and its lighthouse.

Only a few days remain. Who will be the new owner of Little Gull Island? You can help decide!

Deadline: December 10, 2012

The public auction ended on October 17 with a high bid of \$381,000. The above consortium of historical and environmental organizations raised and bid over \$150,000 to purchase *and preserve* Little Gull Island. The GSA assured supporters of this campaign that their decision will take into consideration *the most qualified to preserve*.

Talking Points

Little Gull Island belongs in the public realm under the stewardship of the New London Maritime Society. We fear a bidder may be planning to place wave-energy turbines in the waters off Little Gull Island that would negatively impact its fragile habitat and those of nearby Great Gull and Plum Islands. Proper management of the island habitat is important for Little Gull and neighboring Great Gull & Plum Islands with their populations of endangered bird species and seals. Little Gull Island is part of a local habitat comprised of Little Gull, Great Gull and Plum Islands, one that, if managed correctly, would support the populations of two endangered bird species: the piping plover and the roseate tern (see photos below). Little Gull may also be a seal rookery (see photo on page 1). The U.S. Fish and Wildlife Service agreed to manage the property's habitat if we win the GSA auction.

Little Gull Island's historic lighthouse deserves to be preserved for future generations. Little Gull has an historic lighthouse on it, established in 1806, that deserves preservation. The New London Maritime Society is willing to take on that responsibility; it has 29 years of experience preserving New London's 1833 U.S. Custom House. As one European visitor to our lighthouse noted: "Lighthouses are to maritime America what cathedrals and castles are to Europe" – a part of the living fabric of this nation.
