GOSA also hosted a scavenger hunt for kids on our property. Flyers were printed to inform members of our community about our properties, the benefits of being outdoors, and monthly community hikes hosted by GOSA. Equipment was purchased to support our efforts to share that information at public events.

Stewardship: Funds were used for lumber, screws, bolts, treads, and a cart to carry them to the sites where ramps and other improvements were made to 3 bridges. A battery powered hedge trimmer was purchased for clearing vegetation along trails.
